## MINUTES OF RAMSEY TOWN COUNCIL MEETING held on Thursday 14 July 2022 @ 7pm Ramsey Town Council 7 Church Green, Ramsey

**Present:** - Councillors R Brereton (Mayor,) J Bufton, J Clarke, M Clarke, S Corney, A Costello, V Fendley (Deputy Mayor,) A Lavender, G Rayment, N Soer and P Taylor. **In Attendance:** - G Cook, Town Clerk.

The Mayor welcomed Cllr Taylor to the meeting.

- **74.** Apologies for Absence Cllrs J Palmer and L Renfree.
- 75. To Receive Declarations of Interest -

Councillors Brereton and Corney declared a non-pecuniary interest in Minute No.78, Planning Applications, as Members of the District Council's Development Management Panel and reserved the right to change their view when presented with applications at the Panel.

- **Public Participation** There were seven members of the public present. Work on the pond is scheduled to start the second week in October. Questions were also asked regarding defibrillators and litter bins. Two gentlemen gave a presentation on the Huntingdonshire Volunteer Centre.
- 77. <u>Minutes of the last Meeting to be Approved</u> Minutes of 9 June 2022 were **APPROVED** by 8 votes with 2 abstentions and duly signed.
- 78. Planning Applications for Consideration
  - **1.1 22/01303/TREE** T1 Norway Maple: Tree works, 1A Fairfields Drive, Ramsey PE26 1BT. Unanimously **APPROVED**, no further comment made.
  - **1.2 22/00764/HHFUL** Single storey side extension to house The Cottage, Hollow Road, Ramsey Forty Foot. **APPROVED** by HDC prior to meeting.
  - **1.3 22/01108/HHFUL** Side and rear extensions to single storey dwelling, removal of carport 7A Bury Road, Ramsey. Unanimously **APPROVED**. Proposed extension using existing footprint of the carport will not impact on street scene.
  - **1.4 22/01078/FUL** Erection of dwelling Land between 226 and 232 Oilmills Road, Ramsey Mereside. Unanimously **APPROVED**, no neighbouring objections.
  - **1.5 22/01330/FUL** Proposed erection of 2 dwellings and the relocation of the access point following the demolition of the existing barn Former 79 Ugg Mere Court Road, Ramsey St Marys. Unanimously **APPROVED**, no neighbouring objections.
  - **1.6 22/01327/HHFUL** Single storey side extension The Old Chapel, Chapel Road, Ramsey Heights. Unanimously **APPROVED**, will not impact on street scene.
  - 1.7 22/00655/FUL Part demolition and restoration of existing barn and erection of a new single storey dwelling Land West of The Poplars, Daintree Road, Ramsey St Marys. Unanimously APPROVED, site large enough to accommodate proposed development.
  - **1.8 22/00731/OUT** Erection of two storey house Land at 117 Herne Road, Ramsey St Marys. Unanimously **APPROVED**. Previously approved in 2018.
  - 1.9 22/01413/PIP Application for permission in principle to convert former public house to 4 x 1 bedroom flats 132 Great Whyte, Ramsey. REFUSED by 7 votes with 2 in favour and 1 abstention. Council was of the opinion that the property would be better suited for conversion to a pair of semi-detached houses.
  - **2.0 22/01451/HHFUL** Proposed single storey flat roof extension to rear 14 Lime Road, Ramsey. Unanimously **APPROVED** no further comment made.
